Updated 11/23/25

Proposed Amendment No. 1	Yes	No
Clarification that three is a maximum, not a required number, for the number of individuals to be appointed by the Scarsdale Neighborhood Association Presidents (SNAP) and the Town and Village Civic Club (TVCC) to the Administrative Committee, which supervises election to the School Board Nominating Committee (SBNC).		

## Article II.A.2

**(b).** up to three (3) members appointed in writing by the President of the Scarsdale Neighborhood Association Presidents ("SNAP");

**(c)** up to three (3) members appointed in writing by the President of The Town and Village Civic Club ("TVCC"); and

Replaces references to the Scarsdale Forum with references to the Town and Village Civic Club (dba Scarsdale Forum).		

**Article II.A.2(c).** three (3) members appointed in writing by the President of The Town and Village Civic Club ("TVCC")<sup>1</sup>

Proposed Amendment No. 3	Yes	No
In the case of a tie, the Election Chair will vote to break the tie.		

**Article II.A.3(b).** In the event of a tie vote, the Election Chair may vote to break the tie.

Proposed Amendment No. 4	Yes	No
In the case of inclement weather or an emergency and the SBNC election cannot be held, the Election Chair will determine a plan for an alternate date in consultation with the Administrative Committee.		

**Article II.C.3(g).** In the event that schools are closed, or in the event that the Election Chair determines in their sole discretion in consultation with the Administrative Committee, that the election should be postponed on account of an extraordinary circumstance such as inclement weather or an emergency, the Election Chair, in consultation with the Administrative Committee, will determine and publicize a makeup date for the election.

Proposed Amendment No. 5	Yes	No
Would provide for an option of drop boxes on Election Day.		

**Article II.C.3(g).** The Election Chair may arrange for secure absentee ballot dropboxes at one or more locations in the School District. For votes in dropboxes to be counted, the Election Chair must make arrangements for the dropboxes to be secure and for the ballots deposited in the dropboxes to be reliable and completed by the applicable voter claimed to be the voter in respect of the applicable ballot.

Proposed Amendment No. 6	Yes	No
The Resolution Chair has discretion as to how to pursue dialogue with community members regarding any resolution changes that will appear on the SBNC ballot.		

**Article II.C.4** The Resolution Chair, in consultation with the Administrative Committee, shall arrange for dialogue with community members regarding proposed amendments at least three weeks in advance of the Nominating Committee election to give members of the community an opportunity to comment on proposed changes to the Resolution. No comments from members of the community regarding proposed amendments shall be binding on the Administrative Committee.

Proposed Amendment No. 7	Yes	No
Amend to provide that SNAP and TVCC would no longer have the right to appoint non-voting members to the SBNC		

**Article III.A.2.** Delete all verbiage related to Non-Voting Members

Proposed Amendment No. 8	Yes	No
Allow for follow up after the BOE Candidate presentations to resolve open ended candidacy questions.		

**Article III.C.2(c)(iii).** The Nominating Committee shall adopt a procedure for asking questions of candidates, which may include arranging for more than one round of individualized and differentiated questions, which, for the avoidance of doubt, must comply with the requirements in the second sentence of subclause (i) above.
